Facts arising from the Complaint:

Mr. Saurabh Sharma has filed the present complaint under section 18 of the RTI act (hereinafter 'the act'), with the Commission, stating that respondents 1 to 11, who are public authorities as per the said act, have not updated their manuals which have been published in pursuance of their obligations under section 4 (1) (b) of the act. He has made special reference to manual (xi) of section 4 (1) (b), stating that the budget has not been updated at all.

The Commission has perused the websites of the respondents and has found that the information being displayed *suo moto* i.e. the manuals, have not been updated. **The respondents have failed to update the information inspite of a clear and unambiguous provision for the same in the act, in the form of section 4 (1) (b) (xvii).**

Decision:

The Complaint is allowed.

In view of the aforesaid and from the facts before it, the Commission under the powers vested in it by section 19 (8) (a) of the RTI act, hereby directs the following:-


1. The manuals published in pursuant of section 4 (1) (b) of the act, shall be updated by 5th December 2010.
2. Manual (xi) should be itemized and information must be for the previous two years and there should also be a report on current budget estimates.

3. A sign board of appropriate dimension shall be installed, mentioning the Name(s), designation(s), contact details including the office address/room number, availability hours and telephone numbers of the Central Public Information Officer(s), Central Assistant Public Information Officer(s) and First Appellate Authority, as the case may be, who have been notified under the RTI act 2005 (in case of a change of PIO or Appellate Authority, the sign board will be updated within ten days of the said change.) Information regarding the requisite fees to be paid under various provisions of the RTI Act 2005, modes of payment and the office where such fee will be accepted. Information regarding Information Handbook/manuals published under section 4 (1) (b) of the act; their location and time when they can be accessed should be also mentioned on the board. The exact link/URL to the page on the website of the college/ department where the information handbook can be viewed will also be mentioned. **No acronym/abbreviation should be used.** This information shall be inscribed both in English and Hindi, and shall be installed at a location having maximum public view. This will be maintained by the head of the public authority/ head of institution as the case may be, or the officer(s) so directed by them in writing, so long as the RTI act is in force. This should be done by the 5th of December 2010.
4. The RTI link on the website should read as **“Right to Information”**.

Each respondent shall send a report of compliance of the above directions to this Commission by **10th December 2010**. The report may be sent to rtimonitoring@gmail.com, with a copy to the complainant.

Notice of this decision be given free of cost to the parties.

Any information in compliance with this order will be provided free of cost as per section 7(6) of RTI, Act, 2005.

The information asked for is as under:

1.	What is the exact number of physically and visually challenged Teaching Staff in your college? Provide the employers and their designations.	As per the Expert Committee constituted under the Chairmanship of Addl. Secretary (SJCE) on 2 nd July, 1999, subjects as Humanities, Law and Languages were recommended for employment of the orthopedically and visually handicapped candidates. The college, however, is not imparting education in any of the said subjects. The college imparts education in the professional courses. Therefore, it offers subjects such as Electronics, Food Technology, Instrumentation, Physics, Biology, Mathematics, Chemistry, Bio-chemistry, Computer Science and Bio-medical Science.
