

AMENDMENT NO. 1 TO THE MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN TRANSLATIONAL HEALTH SCIENCE AND TECHNOLOGY
INSTITUTE (THSTI) AND SHAHEED RAJGURU COLLEGE OF APPLIED SCIENCES FOR
WOMEN

This Amendment No. 1 is dated 5th August, 2023 (the "effective date") by and between the TRANSLATIONAL HEALTH SCIENCE AND TECHNOLOGY INSTITUTE, having its office located at NCR Biotech Science Cluster, 3rd milestone, Gurgaon-Faridabad Expressway, Faridabad-121001, Haryana, India, is an autonomous institute of Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India (hereinafter referred to as "THSTI")

AND

SHAHEED RAJGURU COLLEGE OF APPLIED SCIENCES FOR WOMEN located at Vasundhara Enclave, New Delhi - 110096 is a constituent college of the University of Delhi (hereinafter referred to as "Shaheed Rajguru College Of Applied Sciences For Women")

WHEREAS, THSTI and Shaheed Rajguru College Of Applied Sciences For Women entered into an MoU dated as of 5th August, 2020 (the "MoU") for implementing the Science Setu programme in colleges as mentioned in the MoU.



AND

WHEREAS, the THSTI and Shaheed Rajguru College Of Applied Sciences For Women intend to extend the terms of the MoU for further period of three years i.e. up to 4th August, 2026.

3. This Amendment may be executed in one or more counterparts, each of which together shall be deemed original but all of which together shall constitute one and the same document. A photocopy of the original signature of an authorized representative of a party shall have the same validity as an original signature for the purpose of this Amendment.
